# **Privacy Policy**

# 'Hajde!

The Privacy Policy is part of the standard user package that accompanies each of our software products. The main purpose of this document is to contribute to trust between the company and our clients, respecting the most important international standards and domestic legal norms.

In order to ensure easy and simple use of our product, this document contains detailed explanations on the collection and use of your personal data, which are collected, processed and used in accordance with the legal provisions on personal data protection of Montenegro. In this context, the Holder shall take all necessary measures to ensure full compliance with these legal provisions. The mentioned policy does not apply to internet presentations, products and services that do not show or have no connection to this privacy policy or activities that are not related to this application.

The holder of the application "Hajde" is the, hereinafter: the Holder.

### 1. Collection and use of user data

The carrier can use the application and the portal to collect and use personal data in order to maintain the functionality of the application and enable the service that users request. The Holder will securely store your data and take all necessary measures to protect your data from loss, misuse or alteration. The Holder does not sell, rent or lend the list of users of its pages to third parties. The holder may share data with trusted partners for specific purposes: making statistical analysis, providing customer support, or similar needs. Any such third party is prohibited from using your personal information with the obligation of confidentiality.

## 2. Respect data privacy

The holder recognizes and respects the importance of responsible use of data collected through the application "Hajde". The holder respects your rights to access, correct and remove your personal data. The holder may provide you with certain information about products, services and special offers, unless you have decided not to receive this information or if it is prohibited by law. Information may be sent to you, in certain cases if necessary, in order to continue using the application "Hajde" and certain services without interruption. In cases when required by law, the Holder will hand over your personal data to the appropriate services. The holder applies the EU GDPR regulations and guarantees that when processing personal data, it acts professionally in a way that unauthorized persons are not allowed access to the personal data of users of the application "Hajde".

#### 3. Cookies

The application "Hajde" uses the so-called cookies - text files that the web server places on the computer of the user (visitor). Files are created when a browser on the user's device loads the website they have visited, which then sends the browser data and then creates a text file (cookie). The browser sends files to web sites (website, web pages) when the user returns to it for a better user experience and more online opportunities. Saved cookies can be temporary (placed only during visits to websites), or permanent cookies that remain placed on the visitor's computer even after closing the browser. Cookies are used for the functioning of all websites and for a better user experience. The data collected also includes the user's IP address, browser information, language, operating system, and other standard statistics that are collected and analyzed only in anonymous and massive form. The application "Hajde" is completely virus-free, so cookies cannot run any program on your tablet, computer or mobile phone.

If you do not agree to their use, you can easily delete (or prevent) cookies on your computer or mobile device using the settings of the browser you are using. More information about cookies can be found on the browser pages, or at www.allaboutcookies.org. Since the purpose of cookies is to improve and enable the use of our applications, websites and their processes, please note that by preventing or deleting cookies, you may disable the operation of these pages or cause them to work and look different in your browser. The Privacy and Cookies Policy governs the use of cookies and all data collected while using the app, except for third-party cookies. The holder will periodically provide new important information to inform you about how to protect your data on the application. The holder reserves the right to change the cookie policy at any time and we therefore recommend that you check for updates from time to time.

#### 4. Your adherence to these policies and rules

By using "Hajde" services, you agree to the collection and use of data by the Holder, as stated in this rulebook. If the Holder decides to change the privacy policy, changes will be made to this document so that you can always know what data it collects, uses and under what circumstances it will be disclosed. You have the right to revoke your consent to the use of personal data at any time by written notice, as well as all legal rights if you believe that there has been illegal data processing (right to notification, access to data, etc.).
